


# *Journal of Forensic and Legal Medicine*



Faculty of Forensic and Legal Medicine AGM – May 2020

## 1. The Journal

Please find our latest report which details a range of metrics and measures by which we assess the success and travel of the Journal of Forensic & Legal Medicine. I am happy to talk to any of this report at the AGM.

Key points for me to highlight are:

- The increase in article submission, which marks us out as having the second highest submission rate in the Elsevier family of forensic journals after FSI
- The increase in Rejection rate, which reflects the volume of submissions that we receive
- The breadth of geographical regions that we receive submissions from, although we have work to do to improve the acceptance rate from some regions
- The slight decrease in time taken to make decisions and get work online
- Although increasing, citation numbers still need to improve, but downloads are increasing (note how 5 of the Top 10 most downloaded papers of 2020 so far are from the past 2 years)

We have also been considering our Equality and Inclusivity responsibilities too. With this in mind, we undertook a brief examination of the gender of first authors of our main papers over the past three years. The results are below:

As you can see, the Journal has remained surprisingly consistent in terms of the distribution of first authorship. When we look at the first authors of our special publications, we can see that 25% of the Commentaries, 33% of the Editor's Choice and 25% of Special Issue leads are women. This will be something we continue to work on during the coming months and years. Our first task will be to review the Editorial Board membership again, although note that we did make inroads in this regard at the start of 2019.

I would like to give my heartfelt thanks to everyone for their support since we met in Cardiff last year. The fact that the Journal continues to go from strength-to-strength is testament to our collective commitment and efforts. I'd particularly like to thank my Associate Editors who may be less visible than I am but are no less committed. Margaret Stark has stepped down as one of our AEs (due to the demands of the Presidency!) and while we will miss her on the team, I am delighted that Maria Nittis has joined Wilma Duijst and myself, as well as Alex Smith from Elsevier, in leading the Journal.



I'd also like to formally recognise the efforts of our many many peer reviewers who give up their time and expertise to support the Journal and our academic community.




### 2.1. Submitted Manuscripts & Editorial Outcomes




## 2.2. Submitted Articles by Country & Region




Trend of Top 10 Countries & Regions (2019)




### 2.3. Accepted Articles by Country & Region



### 4.1. Full Text Usage per Platform per Year


