

Regional breakdown of corresponding authors (2012 YTD)










Measurements per March 2012

9. Other Comments & Concluding Remarks

- Fraud is an increasing problem for all journals:
 - o Plagiarism
 - o Salami slicing
 - Gift authorship
 - Unauthorised inclusions of names
- Considerable time has been spent by editor-in-chief, production team and publisher in dealing with the complex issues that arise. Principles employed are those declared by the Committee on Publication Ethics.
- Every query raised is investigated.
- JFLM continues to perform well over the past year.
- Editorial times could be reduced somewhat to ensure we have enough copyflow to fill issues in a timely manner.
- JFLM is expected to receive its first Impact Factor in the summer of 2012. Elsevier will conduct the relevant marketing campaigns once Thomson Reuters releases the Impact Factor in 2012.
- EES reviewers and specialty classifications were updated in April 2012 to ensure submissions are clearly identified.
- Reviewers will be mass emailed in July 2012 to update their classifications according to the newly revised list. This will ensure that submissions can be allocated to the appropriate reviewer and hopefully produce better reviews and less time wasted on rejecting review request.
- A Board review is currently under-way and will be completed in the coming months. The new Board will
 be reminded about their tasks of conducting reviews, promoting the journal and encouraging high quality
 submissions to the journal.
